This **Strategic Alliance & Technology Transfer Agreement** is made and entered into on the 19th day of March 2024

WHEREAS, the Parties mutually agree to enter into a Strategic Alliance with Technology Transfer to market and perform certain complimentary business products and services in Australia.

NOW, THEREFORE, in consideration of the foregoing and of the mutual premises hereinafter expressed, the Parties hereto do mutually agree as follows:

3. To share technical and proprietary knowledge that are relevant to this business.

5. This Agreement is an initial document valid for a trial period of two (2) years effective from 19 March 20 till 18 March 2026, hereinafter referred to as the 'trial period'
6. There are no legal obligations upon any parties and this agreement has no legal bindings during the trial period as above-mentioned.

7. **Co Farming Hub Pty Ltd** hereby officially hop onboard the 'Feeding for Health' project initiatives through collaborative effort between **PWD Smart Farmability Sdn Bhd, Global Green Earth Economy Foundation** and **World Humanitarian Drive (WHD) UK, London**, which promotes international education and trade, has been granted 'Special Consultative Status' by **United Nations Economic and Social Council**
